

**ANNUAL TAX LEVY**

An Ordinance levying taxes for all corporate purposes for the COUNTY OF WHITE, ILLINOIS, for the fiscal year commencing on the 1st day of December, A.D., 2016 and ending the 30th day of November, 2017.

**BE IT ORDAINED BY THE COUNTY BOARD, WHITE COUNTY, ILLINOIS:**

**SECTION 1:** That the amounts hereinafter set forth, or so much thereof as may be authorized by law, and the same is hereby levied for such purposes as: General Corporate, Highway, Bridge Construction, Federal Aid Matching, IMRF, Social Security, Tort Immunity, Extension Council Service, Coleman Rehabilitation, Tri-County Health and Tri-County IMRF for the fiscal year of said COUNTY OF WHITE, ILLINOIS beginning the 1st day of December, A.D. 2016 and ending the 30th day of November, A.D., 2017.

**SECTION 5:** This Ordinance shall be in full force and effect from and after its passage, approval and recording, according to law.

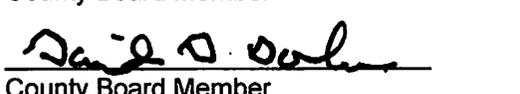
